Do you agree to the agreement terms to setup and vend at the farmers market? YES

We are primarily promoting locally sourced food/produce or artisan-created goods. We reserve the right to restrict the mix of other types of vendors.

Registration & Fees: All vendors must be registered and pre-approved by the market manager. We use a 10% sale-share model, capped at \$30.00. All payments must be made on the day of the market by 1:00pm. **No personal checks will be accepted.**

Schedule: Load-in begins at 8:00am with a 9:00am start. Market closes at 1:00pm.

Compliance: Vendors must secure permits through the Alliance City Health Department and provide proof of insurance or sign a hold-harmless agreement. All required permits must be displayed for public viewing. All vendors must have a state vendor's license, if required by law, and viewable upon request. The sale of food items requires proper labeling, which must contain the product name, ingredients, net weight or units contained in the package, and price. Vendors are responsible for determining what licenses they need.

Our goal is to be a family-friendly event. Smoking, vaping, consumption of alcohol or illegal drugs is NOT PERMITTED in the market area and may result in suspension or termination of contract. The Main Street Alliance Group reserves the right to suspend or terminate the contract of any vendor for conduct deemed inappropriate to the Main Street Farmers Market.

The Main Street Farmers Market is held on **Mechanic Ave., between E Main St. and E Market St.** All vendors *must reserve their spot online at Mainstreetallianceohio.org.* Vendors arriving after 8:30am will not be permitted to drive in the sales area without the Market Manager's

approval. All vehicles must be off Mechanic Ave. by 8:45am. Blocking Main St. and Market St. while unloading or leaving is strictly prohibited.

Electrical outlets are reserved for Food Truck use only. Vendors who need electrical use must supply their own generator.

Vendors who require a space larger than 10'X10' must inform the Market Manager.

The Caboose is reserved for musical entertainment only. Benches and tables are provided for Market guests only.

All waste must be removed from Mechanic Ave. immediately after the Market closes before the vendor leaves. Vendors are responsible for removing their own waste from the parking lot and NOT use trash cans or dumpsters in the vicinity.

Legal: The Vendor shall not hold Main Street Farmers Market, Main Street Alliance Group, Market Manager, or the City of Alliance harmless for any harm to people or property occurring within the market area. The vendors must have their own general liability insurance or be responsible for any damages to the customers, other vendors, or the location.
